Who may become a Scottish Royal Arch mason

- ◆ A Master Mason in good standing in a Craft Lodge of a Constitution recognized by the Grand Lodge of Scotland, is a absolute prerequisite.
- ◆ Candidate must be a Master Mason for at least fifteen months.
- ◆ Companions are expected to maintain qualified Lodge Membership at all times.
- ◆ It is a prerequisite for a affiliating Companion to the Royal Arch, Lodge and Council or Cryptic Degree's, to first obtain the Mark and Excellent master's Degree's in the Scottish Royal Arch. (The Mark Degree can also be obtained in a Craft Lodge).
- ◆ The Companion must be at least be 21 year's of age.
- ◆ Candidates for affiliation must produce proof of good standing in a Chapter, and must be proposed, seconded and balloted for as in the case of Candidates for Exaltation.
- ◆ Candidates who are already regular Mark Mason's must be affiliated in the Mark Degree in the Lodge held within the Chapter before obtaining admission to the Excellent Master and Royal Arch Degrees.
- ◆ No one can be recognized as a Mark Master unless he produces documentary proof that he has received that Degree in a Lodge or Chapter whose right to confer it is recognized by Supreme Grand Chapter.
- ◆ The ballot and affiliation should not be done the same evening.
